ARTICLE VIII: COMMITTEES

Section 2: Operational committees

- A. Will be proposed by the Vice President to sponsor events or research issues that benefit the students and the campus.
- B. All proposed committees must be approved by a three-fourths (3/4) vote of the Student Senate.
- C. Members of the committee will elect a chair. Other members shall consist of any students who are interested.
- D. Operational committees shall be run according to Robert's Rules of Order. If the chairperson relinquishes their duties then a new chair will be elected.
- E. Operational Committees must give a progress report to the Vice-President of Student Senate at regular intervals throughout the semester.
- F. The Student Senate may dissolve any Operational Committee by:
 - 1. Passing a proposal to dissolve the committee with a majority vote.
 - 2. If this vote passes, the Senate must pass the dissolution by a three-fourths (3/4) vote at the next general Senate meeting.

By - Laws

Section 3: Attendance Policy:

Senators are required to serve on an Operational Committee of the Student Senate. Attendance at these committee meetings is subject to the policy described below.

Changed to:

ARTICLE VIII: COMMITTEES

Section 2: Operational Committees:

- A. Standing committee chairpersons will be elected by the floor for the Food, Buildings & Grounds, and Telecommunications committees.
- B. The Vice President will serve as the standing committee chairperson of the Miscellaneous Concerns committee.
- C. Concerns shall be expressed during open forum or to the committee chairperson. If necessary, committee meetings will be held prior to the Senate meeting the following week.
- D. All major concerns presented on the floor that fall under a committee and do not require a committee meeting will be addressed by the appropriate chairperson and results will be reported to the Vice President.
- E. Senators who express a concern that leads to the conduction of a committee meeting are expected to attend the committee meeting about the concern.
- F. After a committee meeting has occurred, a report will be presented to the floor.
